Obuhvaćeni su podaci o isplatama za investicije po osnovnim izvorima financiranja, ostvarenim ukupnim investicijama i ostvarenim investicijama u nova stalna sredstva, prikazana prema karakteru gradnje i tehničkoj strukturi, djelatnosti i sjedištu investitora, te prema djelatnosti namjene i lokaciji investicijskog objekta.

Zbog ne dostavljanja podataka sukladno donesenim Metodološkim uputama od strane Republičkog zavoda Republike Srpske, obrada i publiciranje je izvršeno na temelju anonimnih mikropodataka dostavljenih od strane Republičkog zavoda za statistiku Republike Srpske i kompletne baze podataka dostavljene od strane Federalnog zavoda za statistiku FBiH i Podružnice Brčko.

This publication includes part of the processed data collected by Gross fixed capital formation in 2007 and 2008 - Annual report, filled by the legal entities registered in Bosnia and Herzegovina.

In preparation and conducting of survey, processing and publishing collected data participated: Agency for Statistics of Bosnia and Herzegovina, Federal Office for Statistics of Federation of Bosnia and Herzegovina, Republic Srpska Institute of Statistics and Branch Office Brcko.

The survey has been conducted on the whole territory of Bosnia and Herzegovina by using identical form which was result of common work all statistical institutions.

Included are data on payments for gross fixed capital formation for main sources of financing, realized gross fixed capital formation and realized gross fixed capital formation in new fixed assets, presented by kind of construction and technical composition, by activity and place of investors, by purpose and place of investment.

Due to the fact that data from Republic Srpska Institute of Statistics have not been delivered in accordance with the adopted Methodological directions, data processing and publishing has been based on anonymous micro data delivered by Republic Srpska Institute of Statistics and complete database delivered by Federal Office for Statistics of Federation of Bosnia and Herzegovina and Branch Office Brcko.

METODOLOŠKA OBJAŠNJENJA

Izvori i metode prikupljanja podataka

Podaci o isplaćenim sredstvima i ostvarenim investicijama pravnih osoba rezultat su godišnjeg istraživanja statističkih institucija Bosne i Hercegovine. Prikupljaju se posebnim godišnjim izvještajem "Godišnji izvještaj o investicijama" INV- 01, od svih pravnih osoba registriranih na teritoriju Bosne i Hercegovine, a neposredni su investitori i/ili vode nabavljena stalna sredstva u poslovnim knjigama.

Pod pojmom pravne osobe podrazumijevaju se:

- a) nefinancijska poduzeća,
- b) financijska poduzeća,
- c) proračunski korisnici,
- d) neprofitne organizacije.

Obrazac INV-01 je usuglašen sa međunarodnim statističkim standardima i metodologijama, tj. Europskim sustavom nacionalnih računa (European System of Accounts ESA – 1995) i Sustavom nacionalnih računa UN-a (System of National Accounts – SNA 1993).

Obuhvat i usporedivost

Osnovni cilj istraživanja "Godišnji izvještaj o investicijama" (INV-01) je prikupljanje podataka čijom će se obradom, sukladno zahtjevima nacionalnih računa, omogućiti obračun bruto domaćeg proizvoda rashodnim pristupom, utvrđivanje udijela investicija u bruto domaćem proizvodu, kompiliranje kapitalnog računa i sl.

Obzirom da bruto investicije, sukladno Europskom sustavu računa, obuhvaćaju bruto investicije u stalna sredstva, promjenu zaliha i neto nabavku dragocjenosti, napominjemo da se ovim istraživanjem prikupljaju samo podaci o bruto investicijama u stalna sredstva i neto nabavkama dragocjenosti pravnih osoba.

Ne obuhvaćaju se ni investicije naših pravnih osoba u inozemstvu, osim na ona područja koja se koriste po ugovoru (veleposlanstva, vojne baze i sl.), kao i ulaganja u poslovne jedinice u inozemstvu.

Istraživanje je provedeno na potpunom obuhvatu pravnih osoba. Distribuciju obrasca i prikupljanje podataka organizirali su i obavili Federalni zavod za statistiku Federacije Bosne i Hercegovine, Republički zavod za statistiku Republike Srpske i Agencija za statistiku Bosne i Hercegovine – Podružnica Brčko, sukladno registrima pravnih osobama koji se vode na tim dijelovima Bosne i Hercegovine.

Klasifikacija podataka prikupljenih ovim istraživanjem vrši se na dva načina i to:

- prema pretežnoj djelatnosti i sjedištu investitora, odnosno po tzv. "organizacijskom principu",
- prema namjeni investicije, odnosno prema principu tzv. "čistih djelatnosti".

Podaci razvrstani prema tzv. "organizacijskom principu" pokazuju koja pravna lica (iz koje djelatnosti) investiraju, a podaci razvrstani prema principu tzv. "čiste djelatnosti" pokazuju u šta se i gdje ulaže (u koju djelatnost i na kojoj teritoriji).

Obrada podataka se vrši sukladno Europskoj klasifikaciji djelatnosti NACE Rev.1.1 za razinu dvije broježane oznake.

Podaci se publikuju za razinu jedne slovne oznake, osim za djelatnosti C-Rudarstvo i D-Prerađivačka industrija, gdje se publikuje i razina dvije slovne oznake.

Obrada prikupljenih podataka na teritorijalnom principu se vrši za razinu Entiteta, Brčko Distrikta i Bosnu i Hercegovinu.

Svi podaci su iskazani u tekućim cijenama.

Definicije

Investicije u stalna sredstva podrazumijevaju nabave poduzeća i drugih organizacija radi dobivanja nove imovine, povećanja vrijednosti ili zamjene postojećih stalnih sredstava (stambene zgrade, ostale zgrade i građevine, oprema i uređaji trajnijeg karaktera, pošumljavanje i podizanje dugogodišnjih nasada, rudarska i mineralna istraživanja, softveri i sl.).

Nabavljena stalna sredstva mogu biti kupljena u zemlji i inozemstvu; nabavljena putem financijskog lizinga; mogu biti stečena trampom; primljena kao kapitalni transfer u naturi ili proizvedena i zadržana za vlastitu upotrebu.

Obuhvaćaju se sve vrste ulaganja u nove kapacitete, te za proširenje, rekonstrukciju i modernizaciju postojećih i zamjenu zastarjelih, istrošenih ili uništenih kapaciteta.

Nisu obuhvaćena ulaganja u međufaznu potrošnju, redovito i tekuće održavanje, popravci, nabavka oružja, nabavka stalnih sredstava putem operativnog lizinga, promjene zaliha, nabavka stalnih sredstava za potrebe finalne potrošnje kućanstava, vlasnički dobiti i gubici na stalnim sredstvima nastali kao posljedica nepogoda.

Isplate za investicije u stalna sredstva predstavljaju novčana ulaganja u toku izvještajne godine, bez obzira na vrijeme kada je izvršena izgradnja, izrada ili nabava stalnih sredstava.

Ostvarene investicije predstavljaju vrijednost fizički realizirane izgradnje, izrade ili nabave stalnih sredstava tijekom izvještajne godine, bez obzira na to jesu li stalna sredstva završena i da li je i kada izvršena njihova isplata.

Ostvarene investicije u nova stalna sredstva odnose se na onaj dio stalnih sredstava koji je nabavljen neposredno od izvođača građevinskih radova odnosno proizvođača opreme ili proizveden u vlastitoj režiji, odnosno ona investiciona dobra koja još nisu bila predmet kupoprodaje između neposrednih korisnika tih dobara.

Uključuje se i rabljena oprema nabavljena u inozemstvu, jer utiče na povećanje nacionalnog bogatstva u zemlji. Nije uključena vrijednost otkupa zemljišta, nego samo troškovi prijenosa vlasništva zemljišta.

Investicije u nove kapacitete su ulaganja u izgradnju novih samostalnih jedinica, pogona, puteva, kojih ranije nije bilo ili su imali drugačiju namjenu. Kao novi kapacitet se smatra: cjelokupan objekt kao ekonomska cjelina, dio objekta koji nakon izgradnje djeluje kao ekonomsko tehnička cjelina, nastavak gradnje ili opremanje ranije obustavljenih objekata; ulaganja u dugogodišnje zasade; osnovno stado; nove saobraćajnice i sl.

Investicije za proširenje, rekonstrukciju i modernizaciju su ulaganja u postojeće kapacitete radi povećanja obima proizvodnje ili usluga, radi promjene tehnologije u proizvodnji; proširenje ili preuređenje već postojećeg objekta, ili nabavka novih stalnih sredstava u okviru postojeće radne jedinice.

Investicije u održavanje postojećih kapaciteta su ulaganja radi zamjene zastarjelih ili istrošenih stalnih sredstava, intenzivnije ili racionalnije proizvodnje, ali ne da bi se proširili raspoloživi kapaciteti ili bitno mijenjala sadašnja tehnologija.

Investicije u građevinske objekte obuhvaćaju vrijednost objekta i opreme koja je ugrađena u građevinske objekte (elektro instalacije, instalacije centralnog grijanja, dizala i sl.) i projekti za njih.

Investicije u opremu obuhvaćaju i troškove montaže, prijevoza, carine i osiguranja i druge troškove prijenosa vlasništva.

Investicijama u ostalo podrazumijevaju se ulaganja u osnovno stado, pošumljavanje i dugogodišnje zasade, rudarska i mineralna istraživanja, softvere kupljene ili vlastito razvijene, nabavku književnih i umjetničkih originala, izradu studija, elaborata i sl.

NOTES OF METHODOLOGY

Sources and methods of data collecting

Data on payments and realized gross fixed capital formation in legal entities are the result of the annual data collection by statistical institutions of Bosnia and Herzegovina. They are collected by a separate Annual report on gross fixed capital formation in fixed assets (INV-01 Form), by all legal entities registered in Bosnia and Herzegovina, if they are direct investors and, or acquired fixed assets record in balance sheet.

Under concept legal entities are meant:

- a) non-financial enterprises,*
- b) financial enterprises,*
- c) budget beneficiaries,*
- d) non-profit organizations.*

INV-01 Form is adapted to the international statistical standards and methodologies, that is, to the European System of Account ESA 1995, and System of National Accounts SNA 1993.

Coverage and comparability

The main aim of Annual report on gross fixed capital formation in fixed assets (INV-01 Form) is collecting data in order to enable, within the system of national accounts, calculation of the gross domestic product by a consumption method, establishment of the share of gross fixed capital formation in the GDP, calculation of capital account, etc.

Regard that gross fixed capital formation, according to the European system of accounts, includes gross fixed capital formation in fixed assets, changes in inventories and net acquisitions of valuables, we notice that with this survey only data on gross fixed capital formation in fixed assets have been collected.

Included is not also gross investment abroad except on territory that is used under contract (embassies, military base etc.) and investment in local kind of activity unit abroad.

The survey has been conducted on the full scope of legal entities. Distribution of forms and collecting data have been done by Federal office for statistics of Federation of Bosnia and Herzegovina, Republic Srpska Institute of statistics and Brunch office Brcko, in line with registers of legal entities those are led in their offices.

Data classification collected with this survey has been done using two principles:

- by the main activity and location of investors – so called organizational principle,*
- by the purpose of investment – so called kind of activity and territory principle.*

Data classified in line with organizational principle shows which legal entities (from which activities) are investors. Data classified in line with kind of activity and territory principle shows in which activity and territory investment has been done.

Data processing has been done according to the European Statistical classification of economic activities NACE Rev.1.1 on the division level.

Data are published on the section level except for C – Mining and D – Manufacturing on the subsection level.

Data processing has been done on entities level, Brcko District level and country as whole.

All data are given in current prices.

Definitions

Gross fixed capital formation in fixed assets include purchase of enterprises and other organizations (legal entities) aimed at getting new fixed assets, increasing the value or replacing already existing fixed assets (residential buildings, other buildings and edifices, permanent equipment and installations, afforestation and planting of long-standing plantations, mining and mineral research, software, etc.).

Provided capital formation assets can be purchased in the country and abroad; obtained by financial lease or by barter, as a capital transfer in kind or self produced and kept for own needs.

Included are all kinds of formation in new capacities, in enlargement, reconstruction and modernization of existing and substitution of obsolete, worn-out or damaged capacities.

It does not include investment in intermediate consumption, regular and current maintenance, military weapons, obtaining of fixed assets by operative lease, purchase of fixed assets for final consumption of households, holding gains and losses in fixed assets arose as result of disasters.

Payment for gross fixed capital formation are monetary investments in the year in which the payments were actually made, irrespective of the time when construction or purchase have been done.

Gross fixed capital formation represents the value of physically materialized construction, production or purchase fixed assets throughout a reported year, irrespective of whether they were finished or when the payment was executed.

Realized gross fixed capital formation in new fixed assets are related to the part of fixed assets that has been purchased directly from the contractor or producer of the equipment or self-produced, that is related to gross fixed capital formation assets still out of buying and selling transactions among users.

It is included used assets purchased abroad since it directly influences on nation's affluence.

It is not included the purchase value of land than only the costs of property transfer.

Gross fixed capital formation in new fixed assets is investing in building up of new independent organizations, sections, roads that did not exist, or they had different purpose. As new capacities are considered whole project as economic unit; a part of project that after building up exist as economic and technical unit, continuation of building up or equipping capital projects stopped in the past; investing in planting of long-standing plantations and breeding stock; new roads etc.

Gross fixed capital formation for enlargement, reconstruction and renovation are investments in already existing capacities, in order to enlarge the scope of production or services provision, change in technology; enlargement or renovation of the existing constructions, purchase of new fixed assets in the existing organizational unit.

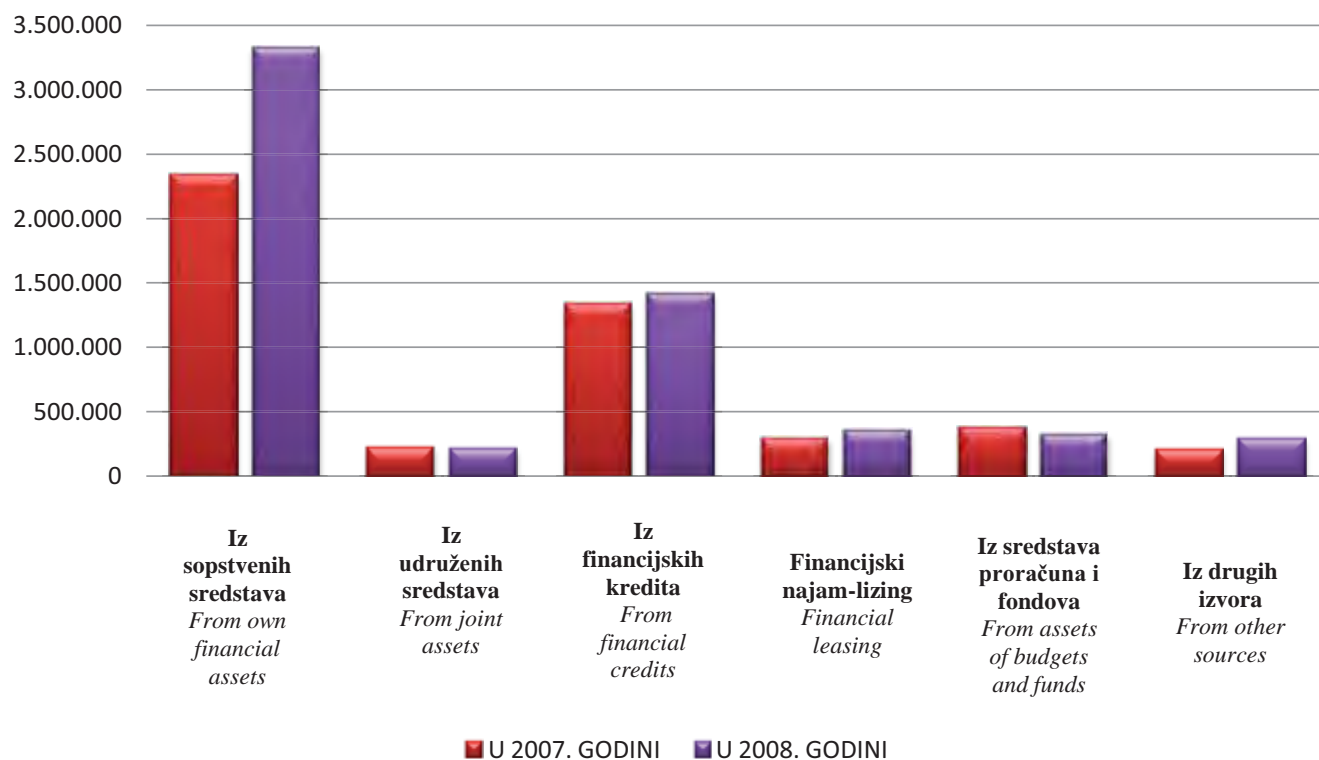
Gross fixed capital formation for keeping of existing equipment are investments in order to change obsolete or worn-out fixed assets, intensify and rationalize production, without expending existing capacities or making more considerable change in the current production technology.

Gross capital formation for construction works includes the value of construction and equipment built-in into constructions (electro installations, central heating installations, lifts etc.) and related projects.

Gross fixed capital formation for equipment includes all expenses for fitting, transportation, custom duties, insurance costs and other costs for property transfer.

***Gross fixed capital formation for other assets** covers investments in breeding stock, afforestation and long-standing plantations, mining and mineral research, software purchased or self-developed, investment in literary and artistic originals making studies and elaborations etc.*

 in 2007 and 2008, thousand KM*

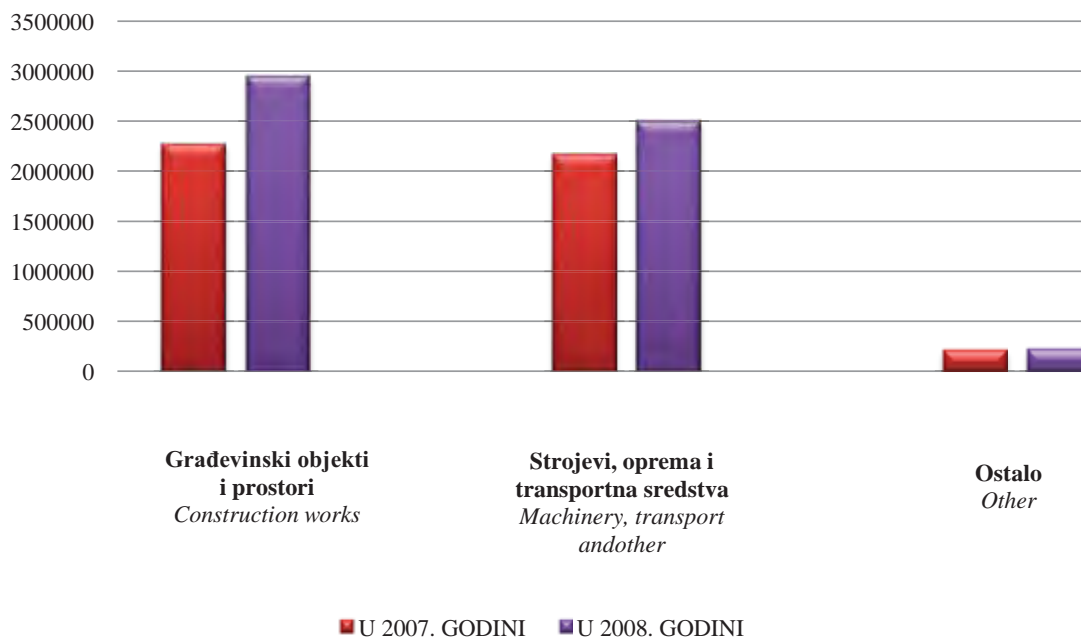
