#### GRANIČNI PROMET PUTNIČKIH MOTORNIH VOZILA I PUTNIKA

I kvartal 2012. godine<sup>1)</sup>

*CROSS-BORDER TRAFFIC OF PASSENGER ROAD MOTOR VEHICLES AND PASSENGERS*

*1<sup>st</sup> quarter 2012<sup>1)</sup>*

U ulazu u Bosnu i Hercegovinu u I kvartalu 2012. godine granični promet putnika iznosio je 3.420.649 putnika. Od ukupnog broja putnika koji su ušli u BiH 42,7% se odnosi na domaće putnike, a 57,3% na strane putnike. U odnosu na ukupan granični promet putnika, 98,2% se odnosi na cestovni granični promet putnika.

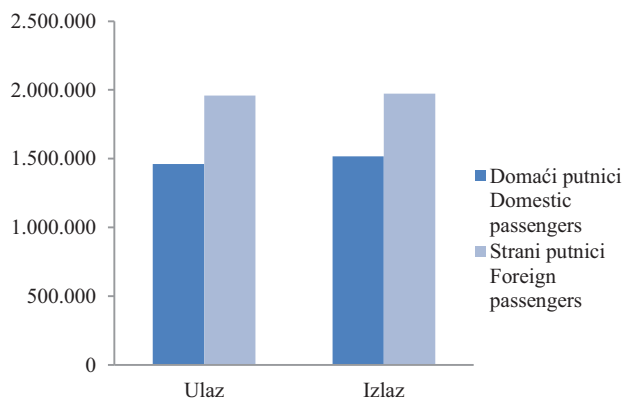
*In the first quarter of 2012 year on the border of Bosnia and Herzegovina incoming traffic of passengers was 3.420.649 passengers. Of the total number of passengers who entered the Bosnia and Herzegovina, 42,7% are domestic passengers and 57, 3% are foreign passengers. In relation to the total cross-border passenger traffic 98, 2% refers to the road cross-border traffic of passengers.*

U ulazu u Bosnu i Hercegovinu u I kvartalu 2012. godine granični promet putničkih cestovnih motornih vozila iznosio je 1.319.368 vozila. Od ukupnog broja putničkih cestovnih motornih vozila u cestovnom graničnom prometu koji su ušli u BiH, 37,5% se odnosi na domaća vozila, a 62,5% na strana vozila.

*In the first quarter of 2012 year on the border of Bosnia and Herzegovina incoming traffic of passenger road motor vehicles was 1.319.368 vehicles. Of the total number of passenger road motor vehicles in the road cross-border traffic that entered the Bosnia and Herzegovina, 37, 5% are domestic vehicles and 62, 5% are foreign vehicles.*

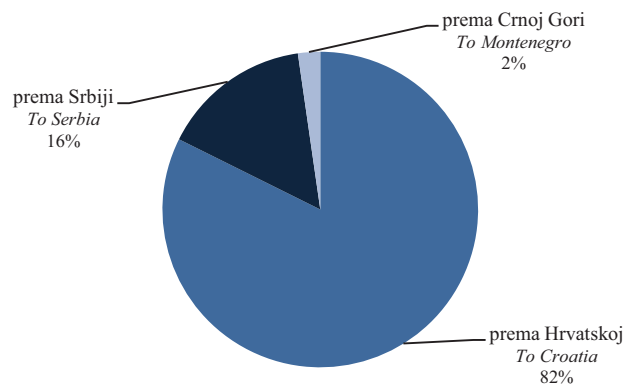

## METODOLOŠKA OBJAŠNENJA

### Izvor prikupljanja podataka

Podaci o graničnom prometu cestovnih motornih vozila i putnika za I kvartal 2012. godine preuzeti su od Granične policije Bosne i Hercegovine.

### Obuhvat

U obuhvat istraživanja uključeni su svi cestovni granični prijelazi, te svi željeznički, pomorski, prijelazi na unutrašnjim plovnim putevima i vazdušni granični prijelazi.

Podaci obuhvataju sva cestovna motorna vozila i putnike koji su prešli granicu i ušli u Bosnu i Hercegovinu, odnosno izašli iz Bosne i Hercegovine.

Putnička cestovna motorna vozila uključuju putničke automobile, motocikle i autobuse.

Putnička motorna vozila razvrstavaju se na domaća i strana. Putnici se prema državljanstvu svrstavaju na domaće i strane.

### Definicije

Granični prijelaz je mjesto namijenjeno prijelazu državne granice.

Granični prijelazi mogu biti međunarodni, međudržavni ili pogranični. Mogu biti cestovni, željeznički, vazdušni, prijelazi na unutrašnjim plovnim putevima i pomorski.

Granični prijelazi za međunarodni promet namijenjeni su graničnom prometu građana Bosne i Hercegovine i građana drugih zemalja.

Granični prijelazi za međudržavni promet namijenjeni su graničnom prometu građana Bosne i Hercegovine i građana susjednih zemalja.

Granični prijelazi za pogranični promet namijenjeni su graničnom prometu građana određenog područja Bosne i Hercegovine i određenog područja susjedne zemlje prema međunarodnom sporazumu.

## NOTES ON METHODOLOGY

### Sources of data collection

Data on cross-border traffic of passenger road motor vehicles and passengers, 1st quarter 2012 of Bosnia and Herzegovina were picked up from Border Police of Bosnia and Herzegovina.

### Coverage

The survey covers all road border crossings and all railway, maritime, inland waterway and air border crossings.

Data covers all road motor passenger vehicles and passengers crossing the border and entering or exiting the Bosnia and Herzegovina.

Passenger road motor vehicles include passenger cars, motorcycles and buses.

Passenger motor vehicles are grouped into domestic and foreign ones. Passengers are grouped into domestic or foreign ones according to the citizenship.

### Definitions

Border crossing is a place intended for crossing the state border.

Border crossings are international, interstates or local ones. They may be road, railway, air, inland waterways and maritime crossings

Border crossings for international traffic are intended for cross-border traffic of citizens of Bosnia and Herzegovina and citizens of other countries.

Border crossings for interstate traffic are intended for cross-border traffic of citizens of Bosnia and Herzegovina and citizens of the neighbouring countries.

Border crossing for local traffic are intended for cross-border traffic of citizens from certain area of Bosnia and Herzegovina and certain area of the neighbouring country according to the international agreement.
