BRUTO DOMAĆI PROIZVOD – RASHODNI PRISTUP 2009

Ekperimentalni obračun – prethodni podaci

GROSS DOMESTIC PRODUCT BY EXPENDITURE APPROACH 2009

Experimental compilation – preliminary data

U cilju unapređenja statistike nacionalnih računa Bosne i Hercegovine, Agencija za statistiku BiH počela je kompilaciju Bruto domaćeg proizvoda prema rashodnom pristupu (BDP). Kao početni, referentni period, za uspostavljanje serije, zasnovane na raspoloživim izvorima podataka, odabrana je 2004. godina. To je prva godina za koju su bili raspoloživi podaci Ankete o potrošnji domaćinstava, čime je osiguran važan izvor podataka o potrošnji domaćinstava. Pored toga, 2004. godina je prva godina u kojoj se raspolagalo podacima o vanjskoj trgovini, koji su kompilirani na bazi carinskih deklaracija, sa obuhvatom za cijelu zemlju. Ove godine, serija obuhvata period od 2005. do 2009. godine.

Kako još uvijek postoje značajne praznine u baznim statistikama raspoloživim za kompilaciju nacionalnih računa, a kvalitet administrativnih izvora podataka ili statističkih istraživanja treba unaprijediti, sačinjene procjene treba smatrati eksperimentalnim procjenama.

Pored toga, treba napomenuti da obzirom na raspoložive izvore podataka i korištene metode, BDP prema rashodnom pristupu, procijenjen je za BiH kao cjelinu.

Revidiranje procjena Bruto domaćeg proizvoda prema proizvodnom pristupu za period 2006 – 2008. godine uticalo je i na revidiranje postojeće serije podataka BDP-a prema rashodnom pristupu u ovom periodu. Također, ove godine je zbog revizije podataka Platnog bilansa BiH koji je sačinila CBBH, izvršena i revizija odgovarajućih kategorija BDP-a.

With a view to improving National Accounts statistics of Bosnia and Herzegovina, Agency for statistics of BiH has started compilation of Gross domestic product by expenditure (GDP). The year 2004 was chosen as the starting reference period for the construction of the series based on available data source. The year 2004 is the first for which data from a household budget survey with countrywide coverage became available thus providing an important data source for estimating consumption of households. That year is also the first for which foreign trade data have been compiled with countrywide coverage based on uniform custom declaration. This year series cover the period from 2005 – 2009.

Since there are still important gaps on the basic statistics available for the compilation of the national accounts and the quality of some statistics based on administrative sources or statistical survey need improvements, composed estimates should be considered as experimental.

In addition it should be noted that taking available data sources and methods used the figures of GDP by expenditure have been estimated for BiH as whole.

Revision of the BDP estimates by the production approach for the period 2006 – 2008 has led to the revision of the existing series of GDP by expenditure estimates in that period. Also, this year due to Balance of Payments data revisions made by the CBBH, appropriate categories of GDP have been revised.

Bruto domaći proizvod prema rashodnom pristupu, procijenjen je za 2009. godinu u iznosu od 27.427 miliona KM, što predstavlja nominalni pad od 2,41% i realni pad od 2,82%, u odnosu na 2008. godinu. Ovo ukazuje na pad cijena od 0,42%.

Izdaci za krajnju potrošnju domaćinstava (79,36% BDP-a) iznosili su u 2009. godini 21.767 miliona KM što predstavlja nominalni pad od 4,14%. Posmatrano u stalnim cijenama, nakon eliminisanja uticaja rasta cijena, potrošnja je opala za 4,21%. Rast cijena duhanskih proizvoda u 2009. godini, od 12,28% imao je za posljedicu nominalni porast izdataka domaćinstava za cjelokupnu grupu proizvoda u koju spadaju i ovi proizvodi, od 7%. Posmatrano u realnim vrijednostima, izdaci za ove namjene su ostvarili pad za 1,4%. Izdaci za troškove stanovanja su ostvarili nominalni porast od 1,14%, dok su izdaci za obrazovanje zabilježili porast od 2,29%. Sve ostale kategorije izdataka domaćinstava su zabilježile nominalni pad, u poređenju sa 2008. godinom. Posmatrano u realnim vrijednostima jedino izdaci za obrazovanje bilježe realan rast od 1,7%, dok su sve ostale kategorije potrošnje domaćinstava posmatrano u realnim vrijednostima, ostvarile pad.

Izdaci za krajnju potrošnju vlade (20,96% BDP-a) porasli su između 2008. i 2009. godine za 3,22% nominalno i 0,97% posmatrano u cijenama prethodne godine.

Bruto investicije u stalna sredstva, (20,56% BDP-a) su opale između 2008. i 2009. godine za 25,04% nominalno i 24,02% realno. Analiza bruto investicija prema vrsti pokazuje nominalni pad, za sve vrste stalnih sredstava.

Izvoz roba i usluga u 2009. u odnosu na 2008. godinu zabilježio je pad od 15,83% u nominalnim i 13,9% u realnim vrijednostima.

Istovremeno, **uvoz roba i usluga** opao je za 22,75% nominalno i 21,44% realno. Udio uvoza roba i usluga BDP-a smanjen je sa 61,10% u 2008. na 48,36% u 2009. godini.

***Gross domestic product by expenditure** is estimated at 27.427 millions of KM in 2009, and represents a nominal decrease of 2,41% and real decrease of 2,82% from 2008 to 2009. These figures imply decrease in prices of 0,42%.*

***Household consumption expenditure** (79,36 % of GDP) reached the amount of 21.767 millions of KM in 2009, and represents a nominal decrease of 4,14%. At constant prices, after discounting the effect of price changes, consumption decreased 4,21%. Rise in the price of tobacco products in 2009. year, from 12.28% had resulted in a nominal increase in household expenditures for the entire group of products which include these products, from 7%. Observed in real terms, expenditures for these purposes have decreased by 1.4%. Expenditure on housing costs have made nominal increase of 1.14%, while expenditure on education reported an increase of 2.29%. All other categories of expenditure of households recorded a nominal decrease in comparison with 2008. Observed in real terms only expenditures for education recorded a real growth of 1.7%, while all other categories of household consumption in constant real terms, decreased.*

***General government consumption expenditure** (20,96% of GDP) grew between 2008 and 2009 by 3,22% in nominal terms and 0,97% in constant prices.*

***Gross fixed capital formation** (20,56% of GDP) decreased between 2008 and 2009 by 25,04% in nominal terms and 24,02% in real terms. The breakdown of gross fixed capital formation by type of assets shows nominal decreases in all type of assets.*

***Exports of goods and services** in 2009 in comparison to 2008 registered an decrease by 15,83% in nominal and 13,9% in real terms.*

*At the same time **imports of goods and services** decreased by 22,75% in nominal terms and 21,44% in real terms. The share of import of goods and services in GDP decrease from 61,10% in 2008 to 48,36% in 2009.*

METODOLOŠKA OBJAŠNJENJA

Bruto domaći proizvod (BDP) prema rashodnom pristupu definiše se kao ukupna domaća krajnja potrošnja korigovana vanjskom bilansom roba i usluga sa ostatkom svijeta. Osnovne komponente BDP-a po rashodnom pristupu su:

- Izdaci za krajnju potrošnju domaćinstava,
- Izdaci za krajnju potrošnju neprofitnih institucija koje usluge pružaju domaćinstvima,
- Izdaci za krajnju potrošnju vlade,
- Bruto investicije,
- Izvoz i uvoz roba i usluga.

Izdaci za krajnju potrošnju domaćinstava sastoje se od izdataka rezidentnih domaćinstava na potrošnju roba i usluga za direktno zadovoljenje ljudskih potreba i želja.

Izdaci za krajnju potrošnju neprofitnih institucija koje usluge pružaju domaćinstvima se sastoje od roba i usluga koje neprofitne institucije pružaju domaćinstvima bez naknade ili u cijenama koje nisu ekonomski značajne.

Izdaci za krajnju potrošnju vlade obuhvata dvije kategorije izdataka: Izdatke za individualnu potrošnju i Izdatke za kolektivnu potrošnju. Izdaci za individualnu potrošnju vlade sastoje se od isplata za netržišne usluge vlade (obrazovanje, zdravlje, socijalnu pomoć, kulturu, sport i td.) i izdataka za tržišne proizvode i usluge (lijekove, ortopedska pomagala, usluge lječilišta i td.) direktno dostavljenih domaćinstvima kao socijalni transfer u naturi.

Izdaci za kolektivnu potrošnju vlade uglavnom se sastoje od izdataka za administrativne, odbrambene, ekonomske, razvojno-istraživačke i druge ne-tržišne usluge vlade.

Bruto investicije se sastoje od bruto investicija u stalna sredstva, promjena na zalihama i neto sticanja dragocjenosti. Bruto investicije u stalna sredstva sastoje se od investicija u nova stalna sredstva, troškova transakcija za postojeća stalna sredstva i nabave neproizvedene aktive. Promjene zaliha odnose se na zalihe proizvodnje u toku, zaliha gotovih proizvoda, zaliha trgovačke robe i zaliha sirovina i materijala.

Podaci o **izvozu i uvozu** roba i usluga temelje se na bilansi plaćanja Centralne banke Bosne i Hercegovine. Vrijednost izvezene robe obračunava se po paritetu fob, a vrijednost uvezene robe po paritetu cif.

NOTES ON METHODOLOGY

Gross domestic product (GDP) by expenditure approach is defined as total domestic final consumption corrected by external trade balance with the rest of the world. The main components of GDP by expenditure are:

- Household final consumption expenditure,
- Final consumption of non-profit institutions serving households,
- Final consumption of general government,
- Gross capital formation,
- Export and import of goods and services.

Household final consumption expenditure consists of expenditure incurred by resident households on consumption goods and services for the direct satisfaction of human needs and wants.

Final consumption expenditure of non-profit institutions serving households consist of goods and services which non-profit institutions provide to households free or at prices that are not economically significant.

Final consumption of general government includes two categories of expenditure: Individual government consumption expenditure and Collective government consumption expenditure. **Individual government consumption expenditure** comprises payment for non-market government services (education, health, social care, culture, sport, etc.) and market goods and services (pharmaceutical and therapeutic products, health resort services) supplied directly to households as social transfer in kind. **Collective government consumption expenditure** consists of expenditure on administrative, defense, economic, R&D and other non market government services.

Gross capital formation is composed of gross fixed capital formation, changes in stocks and acquisition less disposals of valuables. Gross fixed capital formation consists of investments into new fixed capital formation, costs of transactions of existing fixed assets and additions to the value of non-produced assets. Changes in stocks refer to changes of work-in-progress, changes of finished goods, changes of goods in stores and of raw material.

Import and export of goods and services are based on the balance of payments data taken over from Central bank of Bosnia and Herzegovina. The export value of goods is calculated by fob, while import value of goods is calculated by cif.

Procjene u stalnim cijenama

Procjene BDP-a prema rashodnom pristupu, su obračunate i u cijenama prethodne godine, što omogućava poređenje podataka između dvije godine na kvantitativnoj osnovi (nakon eliminisanja efekta promjena u cijenama). Implicitni deflatori agregata i njihovih komponenti su Paasche-ove vrste što znači da oni ne odražavaju samo promjene u cijenama nego i u strukturi rashoda za godine koje se porede.

Izdaci za krajnju potrošnju domaćinstava u stalnim cijenama izračunati su korištenjem raščlanjenih indeksa potrošačkih cijena.

Izdaci za krajnju potrošnju neprofitnih institucija koje usluge pružaju domaćinstvima u stalnim cijenama dobijeni su korištenjem indeksa potrošačkih cijena i indeksa zaposlenih.

Izdaci za krajnju potrošnju vlade u stalnim cijenama obračunati su deflacioniranjem nabavljenih roba i usluga općim indeksom potrošačkih cijena i indeksom rasta neto plaća.

Bruto investicije u stalna sredstva u stalnim cijenama su dobijene deflacioniranjem tekućih vrijednosti ponderisanim indeksom za glavne trgovačke partnere za pojedine robe. Procjene za građevinske radove u stalnim cijenama su dobijene korištenjem implicitnog deflatora outputa u građevinarstvu.

Izvoz roba i usluga u stalnim cijenama je obračunat korištenjem posebno kompiliranim „unit value indexom“, Paasche vrste.

Estimates at constant prices

Estimates of GDP by expenditure were calculated at prices of previous year, thus allowing the comparison of the data between these two years on a quantitative basis (after eliminating the effect of changes in prices) The implicit deflators of the aggregate and its component are of Paasche type, which implies that they reflect not only changes in prices but also changes in the composition of the expenditures between years compared.

Household final consumption expenditure at constant prices was calculated using disaggregated consumer price indices.

Final consumption expenditure of non-profit institutions serving household at constant prices were obtained using consumer price indices and employment indices.

Government final consumption expenditure at constant prices was calculated deflating purchased goods and services by general consumer price indices and indices of net wages and salaries.

Gross fixed capital formation at constant prices were obtained by deflation of current values by weighted price index of the main trade partners for these capital goods. Estimates for construction assets were deflated using implicit deflator of output of the output of the construction industry.

Export and import of goods and services in constant prices were calculated using specifically compiled unit value indices of a Paasche type.
